- THERE WILL BE NO SPACES GIVEN AFTER AUGUST 30, 2024.
- The TOB Festival is not responsible for monitoring dealers within the same organization.

VENDOR POLICES

NO VENDOR VEHICLE WILL BE ALLOWED TO ENTER THE FESTIVAL'S DESIGNATED AREA AFTER 9:00 AM OR BEFORE 4:00 PM. This will be enforced!

- Any FREE Food, other than water, being given by informational booths is limited to only those items not sold by paying food vendors. Please indicate on form ALL items being given free.
- All vendors are responsible for their own sales tax and insurance.
- · Exhibitors and vendors are allowed to conduct business ONLY in the booth space rented.
- Signs, Flyers, or other information is not to be posted in any other locations except your designated area and/or placed on any vehicles – ITEMS WILL BE REMOVED & DISCARDED
- All participants are expected to respect the rights of others.
- The Taste of Brunswick Festival Committee, Town of Lawrenceville, Brunswick County, Brunswick County Airport, nor any other person or organization associated with the festival is responsible for you or your belongings while attending the festival. This includes set up prior to the festival and any items not taken down immediately after the festival.
- · Political candidates may ONLY campaign within their rented booth space.
- No abusive or vulgar language or signage will be tolerated at any time during this event.
- A maximum of two spaces will be rented to any one single vendor.
- Electricity is available by request, however is LIMITED. When making an electricity request, you must provide your intended use for the electricity.
- Taste of Brunswick Festival reserves the right to reject any vendor application and refuse any organization or individual from participating for reasons including, but not limited to, prior rule violations, subject matter, violence, or other misconduct.
- No refunds will be made unless the application is not accepted. Refunds will not be made due to cancellation on the part of the vendor. This is a rain or shine event, and there will be no reimbursement of booth payment due to inclement weather.
- The Taste of Brunswick Festival committee reserves the right to update these rules as necessary, and any updates will take precedence over existing rules.
- Being on Brunswick County grounds, the Taste of Brunswick Festival, its policies, and its vendors will be subject to any restrictions by local government.
- Anyone in violation of any of these rules may be asked to leave and many not be permitted to return to future events.
- Due to COVID-19 mandates continuing to change, additional requirements may be announced at a later date.
